

## EMERGENCY DECLARATION IS A FRAUD

### MASK “ORDER” ARE NOT AN “ORDER” AT ALL

Governor Kate Brown issued an executive order declaring a State wide emergency in May 2020 and then extended it to July 6, 2020.

In her executive order she cites ORS 401.168 and 401.204 as her authority.

The first point to make is that ORS 401.168 states, “the Governor has complete authority over all executive agencies of state government and the right to exercise, within the area designated in the proclamation, police powers vested in the state by the Oregon Constitution”

One problem is, according to Oregon Supreme Court Justice Linde, there is no wording of “police power” within the Oregon Constitution, and that leaves only a “doctrine” of “police power.”

Black's Law dictionary defines “doctrine” as, “a rule, principle, theory, or tenet of the law;”

Merriam-Webster defines “tenet” as : “a principle, belief, or doctrine...”

A State can not lawfully infringe on the Peoples specifically declared individual protections within that States Constitution, the US Constitution or even legislative acts relying on mere “doctrine.”

If it ain't on the page it ain't on the stage.

Of course the courts, politicians and law enforcement violate this much of the time, so for argument sake, let's “theorize” that the Oregon Constitution's preamble is where the State actors have “derived” their “belief” that they have a Constitutionally based authority to violate the Peoples specifically enumerated protected Rights in an “emergency” or otherwise.

The US Supreme Court ruled in *Mugler v. Kansas* that police power of the state was "no more than the power to promote public health, morals, and safety." They did NOT rule that it means the power to demand through threat of punishment, it ruled it means to “PROMOTE.”

Promote: to encourage people to like, buy, use, do, or support something.- Cambridge Dictionary

Encourage: to make someone more likely to do something, or to make something more likely to happen.- Cambridge Dictionary

The Oregon Constitution's preamble states, “We the people of the State of Oregon to the end that Justice be established, order maintained, and liberty perpetuated, do ordain this Constitution.—“

This preamble seems kinda close to what the US Supreme Court ruled that constitutes a States “police powers” even though it doesn't mention public health, morals, OR safety.

So, let's, again only for argument sake, stipulate that “order maintained” grants a “police power.”

In a vacuum this seems to bestow nearly unlimited power of the State to maintain order, however, that

“grant” is not given in a vacuum.

If you will notice, “maintain order” is enclosed on one side with “Justice be established” and on the other side with “liberty perpetuated.” The word “and” is used to designate that ALL three listed intentions are included and of equal force.

This means that while the State is “maintaining order” it must also (and), at the same time, establish justice AND PERPETRATE LIBERTY.

Black's Law dictionary defines “liberty” as, “Freedom; exemption from extraneous control. The power of the will, in its moral freedom, to follow the dictates of its unrestricted choice, and to direct the external acts of the individual without restraint, coercion, or control from other persons. See Booth v. Illinois, 184 U. S. 425, 22 Sup. Ct. 425, 46 L. Ed. 623 ; Munn v. Illinois, 94 U. S. 142. 24 L. Ed. 77; People v. Warden of City Prison. 157 N. Y. 116, 51 N. E. 1006. 43 L. R. A. 264, 68 Am. St. Rep. 7i” Merriam Webster defines “liberty as,” the quality or state of being free: **a:** the power to do as one pleases **b:** freedom from physical restraint **c:** freedom from arbitrary or despotic control **d:** the positive enjoyment of various social, political, or economic rights and privileges **e:** the power of choice.

Boviers Law dictionary from 1856 defines “Liberty” as, “Freedom from restraint. The power of acting as one thinks fit, without any restraint or control, except from the laws of nature.”

Perpetrate: 1: to bring about or carry out 2: to produce, perform, or execute.

Establish: This word occurs frequently in the Constitution of the United States, and it is used there in different meanings: (1) to settle firmly, to fix unalterably; as in to establish justice, which is the avowed object of the Constitution;

Both “perpetrate” and “establish” cause something to happen (justice and liberty) where to “maintain” is to keep things from happening that disrupt order, to keep things the same.

The tyrant, in an interview with KTVZ News states when referring to attempting to trick people into believing she has lawful authority to tell you what to wear admits, “and this is going to be a culture change for businesses across the state...”

You may think the tyrant maybe had a slip of the tongue, maybe, cept here she says it again, “It’s absolutely a culture change.” Do we really need to go read the communist manifesto to figure out what this communist tyrant is attempting to do, I’m sorry TYRANT, you have no authority to force “cultural change” on the People of Oregon.

A big part of “Justice” is Due Process and that the laws not be vague or ambiguous, what exactly is the “appeal process,” the redress to a tyrant writing Emergency declarations when no Emergency actually

exists, certainly not Statewide? I'll answer this at the end.

In Jackson County, Oregon, where I live, as of yesterday (July 01, 2020), we had 110 “probable” cases and ZERO deaths in a county of approximately 335,000, that is a .03% rate of COVID cases.

In what universe exactly is a ZERO percent death rate and a .03% “probable case” rate an emergency?

ORS 401.025: "Emergency" means a human created or natural event or circumstance that causes or threatens widespread: (a) Loss of life; (b) Injury to person or property; (c) Human suffering; or (d) Financial loss.

What does “widespread” mean? It is subjective, undefined and therefore vague and ambiguous.

What about “Human suffering?” Again, subjective, what makes you suffer I could enjoy, undefined, vague and ambiguous.

How much financial loss? I lost my cellphone yesterday does that count? What if a dollar bill falls out my pocket and I don't notice? Subjective, undefined, vague and ambiguous.

So here we have the Oregon tyrant declaring an “emergency” including Jackson County that has a ZERO death rate and a .03% “probably” case rate. Is .03 widespread? The only thing I'd say is “widespread” is the ZERO DEATHS.

How long until this tyrant decides to ban cars under an emergency edict? Ridiculous you say, why? Traffic accidents in Jackson County for 2017 (newest data I could find) were 24 traffic deaths in Jackson County, THAT IS TWENTY FOUR TIMES THE DEATH RATE OF COVID, for which we are in a “state of emergency.” Give them an inch and they take a mile, that would be the mile you thought was yours.

The Oregon tyrant is deceptive in nearly every word she speaks, for instance, “We know that businesses out there have already been able to do it, Costco being a great example.”

I for one do not believe the tyrant is stupid... criminal, an accessory to murder, a liar, a communist and a tyrant among other unpleasant characteristics yeah, but not stupid, so to use Costco as an example of a business forcing its customers to wear masks is disingenuous as Costco is a club and not open to the “general public” Costco can therefore require their “MEMBERS” to hop around on one foot to shop if they want.

To “maintain order” is and has been the big stick of tyrants because the government schools have taught us that “to maintain order” is to simply obey orders.

Maintain: to keep in an existing state: preserve from failure or decline 2: to sustain against opposition or danger: uphold and defend: to continue or persevere in: CARRY ON, KEEP UP.

Clearly to maintain is basically to protect the status quo, like our existing culture, however, the tyrant likes to use “sustain against opposition” as the only definition and ignores the fact that even if that was the intent of the authors there is STILL the Justice and Liberty clause preventing that from being used as a club to beat the People into submission with.

Opposition to the destruction of the rule of law was the intent, by the way, but who does the tyrant clown support, defend and protect?

financial ruin.
