Is it possible to appear “sovereign,” but in reality not be?

Most are familiar with the stories of the founding of this “nation,” the King got bad the colonists got mad and told the mean ole King whats what. The King took that badly and the colonists were forced to violently drive the Kings killers from the land, so far so good, and the crowd cheers. But wait, there's more.

Next, the trusted representatives of the colonies made a treaty with the King that has been dubbed a “peace treaty.”

Many of you may believe that treaty facilitated the foundation of a new sovereign nation.

What if you come to find that it was actually a renegotiated contract of servitude?

The Definitive Treaty of Peace 1783 states, “In the Name of the most Holy & undivided Trinity.

It having pleased the Divine Providence to dispose the Hearts of the most Serene and most Potent Prince George the Third, by the Grace of God, King of Great Britain, France, and Ireland, Defender of the Faith, Duke of Brunswick and Lunebourg, Arch-Treasurer and Prince Elector of the Holy Roman Empire etc.. and of the United States of America,...

The first paragraph is all we need to read of this treaty to discover that the “united States of America” is no sovereign nation but a vassal of the English bankers (fed reserve).

The trusted representatives of, supposedly, the people signed a treaty with their enemy that they had claimed to have defeated in war yet bestow upon him, their supposed defeated enemy, the position of “Arch- Treasurer and Prince Elector of the United States of America,...

Perhaps we need to find out what is an “Arch- Treasurer” and “Prince Elector” to comprehend the significance of this betrayal.

I do not count the signing of this treaty or the agreement to the terms of it as a betrayal in and of itself, the betrayal is passing off a renegotiated terms of enslavement as though it was a great victory creating a sovereign nation. Lies, ofucastionn and deception from them that we have placed trust in is betrayal.

“Arch-Treasurer” simply means Chief Treasurer. *The Anglo-American Encyclopedia and Dictionary*

A chief financial officer (CFO) is a financial controller who handles everything relating to cash flow, financial planning, and taxation issue, is often the highest financial position in a company.

“Arch Treasurer” and “Chief Financial Officer” appear to be synonymous, other than, one applies to government and the other to business.

Is the “United States” a sovereign nation or a rebooted version of the tyrant King's East India Company?

By Treaty, the King (Queen) of England, and the bankers that own them, are, what amounts too, the Chief Financial Officers of the United States that handles everything relating to cash flow, financial planning, and taxation.
